Release and indemnification acknowledgement Charlottetown Dragon Boat Festival

I understand that participating in dragon boat racing involves inherent risks, including but not limited to exposure to water, risk of capsizing, physical exertion, weather conditions, collisions, and potential for injury or drowning. I agree to indemnify, defend, and hold harmless the Release Parties from any and all claims, damages, losses, liabilities, judgements, cost and expenses (including legal fees) incurred as a result of any claim made by a third party related to our team's participation in the Event, including any violation of this agreement or applicable laws.
- 4. I authorize the Event organizers to secure medical treatment for any team member in the event of injury or illness. I understand that I am responsible for any associated medical cost.
- 5. I grant permission to the Charlottetown Dragon Boat Festival to use photographs, video, and audio recordings taken of me and my team during the Event for promotional or educational purposes, without compensation.
- 6. I agree that my team will abide by all rules and regulations of the Event and will follow the directions of Event Officials. We will act in a manner that promotes safety, good sportsmanship, and respect for others.
- 7. I understand and acknowledge that the Event my be canceled or delayed due to severe weather or other circumstances beyond the control of the organizers. In the event of cancellation, the **registration fee is non-refundable.** All proceeds will be used to cover Event expenses and will continue to support designated charitable donations or community initiatives as originally intended.
